Health & Safety Statement

7. Due consideration to the environmental effects of its business including limitation of damage to nature, pollution and nuisance, the reuse and recycling of materials and the requirements of the company's environmental policy.

These policies are the direct concern of Franklyn Yates Engineering Limited. The effects of these policies will be kept under constant review and the resulting information and statistics produced on an annual basis.
